

## **Meter Data Management Services**

### **Advanced Meter Reading (AMR)**

- Remote meter interrogation of hourly power performance and output data;
- Daily processing/validation of revenue-grade generation and/or load data;
- Collect and validate meter reads to ensure complete and accurate data.
